



STANDARDS FOR PUBLICATION IN BRAZILIAN HEALTH AND ANIMAL PRODUCTION MAGAZINE - RBSPA

GENERAL GUIDELINES

The Brazilian Journal of Animal Health and Production - RBSPA journal is an electronic publication, with access and submission of articles exclusively over the Internet (<https://mc04.manuscriptcentral.com/rbspa-scielo>). Published at the Federal University of Bahia, it is intended for the publication of original scientific research articles in the following sections:

- Agribusiness;
- Forage and pasture;
- Preventive veterinary medicine;
- Animal genetic improvement;
- Animal morphophysiology;
- Animal nutrition;
- Pathology and clinics;
- Animal production and environment;
- Fishery / aquaculture resources; and
- Animal reproduction.

Literature reviews covering subjects in the same sections are eventually evaluated exclusively by invitation of the Editorial Board.

Papers submitted for publication are submitted for approval by the Editorial Board, with advice from experts in the field (ad hoc reviewers). The opinions have impartial character and absolute secrecy, from the authors and the reviewers, without identification between them. Articles whose texts require revisions or corrections are returned to the authors and, if accepted for publication, become the property of

RBSPA. The concepts, information and conclusions contained in the work are the sole responsibility of the authors.

The authors must have an ORCID registration. Registration for ORCID generation can be done for free at <https://orcid.org/>.

Manuscripts should be written in impersonal form, double line spacing (except in tables and figures), Times New Roman font size 12, in A4 size white sheet (21.0 X 29.7 cm), with margins of three cm, pages numbered sequentially in Arabic numerals, not exceeding 20, including tables and figures (including for review articles). Pages should have numbered lines. The numbering is done as follows: File menu / Page setup / layout / line numbers ... / number lines).

Do not use non-standard abbreviations and acronyms such as: "T2 was smaller than T4, and did not differ from T3 and T5". When using such writing, it is difficult for the reader to understand and the fluidity of the text. Avoid unnecessary acronyms throughout the text.

Quotations in the text: They are mentioned for the purpose of clarifying or completing the author's ideas, illustrating and supporting statements. All documentation consulted must be cited as a result of copyright. Author citations in the text are in lower case letters, followed by the year of publication. When there are two authors, use & (ampersand) and, in the case of three or more authors, cite only the last name of the first, followed by et al. (non-italic). Mention is made of the date of publication which should be



cited in parentheses, right after the author's name. Quotations at the end of the paragraph should be enclosed in parentheses and separated by semicolons, in chronological order. The article should not have bibliographic references from publications in technical-scientific events (congress proceedings, symposiums, seminars and the like), as well as theses, dissertations and internet publications (which are not part of scientific journals). Therefore, it should be privileged articles published in journals with editorial board (observe percentage and chronological guidelines in the last paragraph of the item "References").

Citation (apud): not accepted.

Language: Articles submitted may be in Portuguese, English or Spanish. However, if accepted for publication, English translation is required upon presentation of the translation certificate by RBSPA-accredited companies. Translation costs will be borne by the authors.

All articles, upon acceptance, must be accompanied (as a supplementary document) by proof of translation or proofreading by a reputable translation / proofreading service provider. Below is a list of suggestions from translators / brokers of scientific articles:

Table: should be referred to in the text as Table (in full) and refers to the

alphanumeric dataset sorted in rows and columns. They are constructed only with horizontal lines of separation in the header and table end. The caption is initially given the word Table, followed by the order number in Arabic numeral (Ex.: Table

1. Average daily gain of sheep fed dietary lipid sources). The table title should be formatted so that, starting from the second line, the text starts below the first letter of the title and not the word Table. At the end of the title should not contain period. Frames are not accepted.

Figure: should be mentioned in the text as Figure (in full) and refers to any illustration constituted or that presents lines and points: drawing, photography, graphic, flowchart scheme, etc. The drawings, graphs and similar should be made with black ink, with high sharpness. The photographs, in the size of 10 ×15 cm should be clear and of high contrast. The subtitles are initially given the word Figure, followed by the order number in Arabic numerals (e.g.: Figure 1. Gir milk production under thermal stress in the years 2005 and 2006). Attention is drawn to the proportions between letters, numbers and overall dimensions of the figure: if there is a need for reduction, these elements are also reduced and are at risk of becoming illegible. The title of the figure should be formatted so that from the second line the text starts below the first letter of the title and not the word Figure. Likewise, at the end of the title there should be no period. Tables and figures should come as close as possible to each other after their call in the text.



TYPES AND STRUCTURE OF ARTICLES FOR PUBLICATION

1) Scientific articles: should be divided into the following sections: title, title in English, authorship, abstract, keywords, summary, keywords, introduction, material and methods, results and discussion, acknowledgements (optional) and references;

2) Review articles: must contain: title, title in English, authorship, abstract, keywords, summary, keywords, introduction, development, conclusions, acknowledgements (optional) and references.

The titles of each section should be typed in bold, justified on the left and in capital letters.

Title: In Portuguese (bold) and English (italics), typed only with the first letter of the sentence in capital letters and centered. They should be concise and indicate the content of the work. Avoid insignificant terms such as "study", "examination", "analysis", "effect", "influence", "evaluation", etc. Do not exceed 20 terms.

Authors: The nomination of the authors should come immediately below the title in English. Enter the last surname in capital letters, followed by the pre-names (with only the first letter in capital letters) also in full and complete, separated by commas and centered (Ex.: OLIVEIRA, João Marques de). Each author must be assigned a superscript Arabic number at the end of the last name, which will be used to identify the information related to him. Just below the names of the authors, the corresponding numbering should be justified on the left and in ascending

order, followed by the affiliation of the author: Institution; Unit; Department; City; State and Country. The author must be indicated for correspondence with the respective electronic address.

Abstract and Abstract: They must contain between 200 and 250 words each, in a single paragraph. Do not repeat the title. Each sentence should be information and not contain citations. It should begin with the objectives, brief methodology, and present the results followed by the conclusions. Any and all acronyms should be preceded by a full explanation. When submitting articles in another language, the abstract should be in Portuguese.

Keywords: Between three and five, should come in alphabetical order, separated by commas, without a period, with information that allows the understanding and indexing of the work. Keywords that already appear in the title will not be accepted.

Introduction: Must contain at most 2,500 characters with spaces. Explanation in a clear and objective way of the investigated problem, its pertinence, relevance and, at the end, the objectives with the accomplishment of the work.

Material and Methods: (except for review articles): Subtitles are not accepted. They must present a logical sequence of the description of the place, the period of the research, the treatments, the materials and techniques used, as well as the statistics used in data analysis. Routine techniques and procedures should only be referenced. Research involving human beings and animals must submit an opinion of



approval by the Ethics and Biosafety Committee of the institution.

Results and Discussion (except for review articles):

The results may be presented as an element of the text or together with the discussion, in plain text or through illustrations. Interpret the results consistently and avoid unnecessary comparisons. Comparisons, when relevant, should be discussed and made in order to facilitate the reader's understanding. The conclusions are mandatory, should be presented at the end of the discussion and not as an independent item. They should not be repetitive of the results and should respond to the objectives expressed in the article. Development (exclusive for review articles): It should be written in a critical way, presenting the evolution of the knowledge, the existing gaps and the current state of the art based on the theoretical framework available in the literature consulted.

Acknowledgments: They should be written in italics.

References: They should be listed in alphabetical order by last name and include all those cited in the text. The last surname should be mentioned in capital letters, followed by a comma and the initials abbreviated by periods, without spaces. Authors should be separated by a semicolon. Type them in single space, with left justified alignment. The references must be separated from each other (the separation must follow the paragraph/spacing path and select: then six points). The typographic resource used to highlight the title element will be bold and, for scientific names, italic.

The norms ABNT-NBR-6023 - August 2002 are adopted.

At least 70% of the references must be from articles published in the last ten years. References of books, annals, internet, theses, dissertations, monographs will not be allowed, except if their insertion in the article is justified and provided that it does not exceed 30% of the total.

ORIENTATION AND EXAMPLE FOR REFERENCE

Periodicals: The titles of journals should be mentioned without abbreviations and in bold. It is not necessary to cite the place, only the volume, the number, the interval of pages and the year. Example:

MELO, T.V.; FURLAN, R.L.; MILANI, A.P.; BUZANSKAS, M.E.; MOURA, A.M.A. de; MOTA, D.A. Roof pitch and exposure and different roofing materials in reduced models of animal production facilities in the fall and winter. **Revista Brasileira de Saúde e Produção Animal** [online], v.16, n.3, p.658-666, 2015.

1. A file with the text of the article in the article submission field with the illustrations (if any) in B/W.

2. Article Forwarding Form, completed and send to e-mail: rbspa@ufba.br

3. Proof of payment of the article submission fee (initial stage of the process) in the amount of R\$ 50.00 (fifty reais). Send to e-mail: rbspa@ufba.br

It is essential to submit this receipt along with the Forwarding Form duly completed for the article to continue processing.

4. Proof of payment of the publication fee (final stage of the process).

Publication fee: at the time of approval (press) will be oriented to the payment of the Union Collection Form (GRU), in the amount of R\$220.00. (two hundred and twenty reais).
